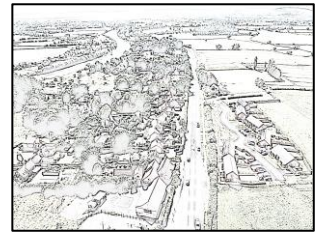


Minsterworth Parish Council

The Parish held its 'Annual Meeting of the Parish Council' on Wednesday 10th May 2023.

All Councillors were elected and Councillor Roger Blowey and Councillor Nick Powell were elected as Chairman and Vice Chairman for another 4 years.

In addition to Parish Council Elections, the Borough and County Council elections were held on the 4th May. Councillor Jill Smith was re-elected as Tewkesbury Borough Councillor and Councillor Paul Mclain was duly elected as Gloucestershire County Councillor. The Parish Council would like to congratulate and look forward working together.

Councillor R Blowey presented his annual report and thanked his fellow Parish Councillors, Tewkesbury Borough and County Councillors for their input into the running of the Parish Council. This year has seen the sad loss of County Councillor Phil Awford, who was a big supporter of our village, and will certainly be missed.

Work continues on the A48 safety and huge amounts of time and effort have been expended by the Parish Council and the hard work of Councillor Ruth Thomas.

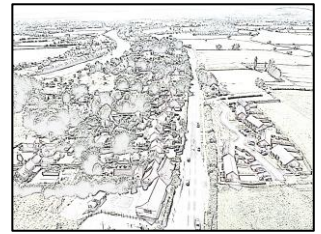
The Parish Council continues to deal with Planning Applications and developments. We understand the frustration of residents when dealing with proposed planning and the Parish Council are aware of the importance of communication. We have implemented some processes for instance adding planning applications, when the clerk receives notification on the website and in the Villager. The Council has a short period of 21 days to respond and will request an extension if required, which will be granted at the discretion of the planning officer. Small planning applications will be discussed at a Monthly Council meeting however larger developments the residents will be consulted.
