## REGISTER OF MEMBERS' INTERESTS

### NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

I, RUTH THOMAS a Member of the MINSTERWORTH Parish Council ("the Parish Council"), set out below under the appropriate headings the interests which I am required to declare under the Localism Act 2011 and the Parish Council's Code of Conduct and I have put 'none' where either I have no such interests under any heading or I am unaware of such an interest.

### PART A

#### DISCLOSABLE PECUNIARY INTERESTS

Members are required to register not only their own interests but also those of their husband or wife, civil partner or of any person with whom they are living as if husband or wife or as civil partners when such interests are known by them.

This includes any payment or financial benefit from a Trade Union within the meaning of Trade Union and Labour Relations (Consolidation) Act 1992.

#### 3. CONTRACTS

Any contract which is made between you or the persons referred to above (or a body in which you or they have a beneficial interest) and the Parish Council a) under which goods or

services are to be provided or works are to be executed; and b) which has not been fully discharged.

I understand that under Section 29 of the Localism Act 2011 there is a legal requirement for the Register of Members' Interests to be published on the internet.


