Financial-

- AGAR- The paperwork has been completed and the internal audit signed off by K King.
 All paperwork and documentation has been submitted and notice placed for public view.
- The approved Build back better funding of £1048.20 will be paid in to the Parish bank account in July 2025.
- GCC has issued the legal notification for speed limit changes on the lower lanes and invoiced the amount requested of £3048.00 towards the 20MPH scheme. An amount of £2000 was agreed and has been allocated to reserves for the remainder of the balance. The PC will need to approve this payment through a majority vote.
- Following budget allocation of funding of £400 towards training, I would like to request to booking in FILCA and ILCA training through the SLCC. These are the prerequisite courses to the CILCA professional qualification. Cost of £144 per course which are based online.

- The Playground inspection was carried out in the last week of June 2025. The report has
 now been received and distributed to the PC. Any repairs required will be quoted for
